The **Philippine Coast Guard** now invites bids for the procurement of the following:

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

Interested bidder may obtain further information from Philippine Coast Guard and inspect the Bidding Documents at the address given below from Monday to Friday, during office hours from 8:00 AM – 5:00 PM.

A complete set of Bidding Documents may be purchased by interested Bidders from **05 November 2020 to 25 November 2020** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount indicated above.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

The **Philippine Coast Guard** will hold a **Pre-Bid Conference** on **13 November 2020, 09:00 A.M** at **National Headquarters Philippine Coast Guard (NHQPCG) Conference Room, 2F Admin Building, 139 25th St Port Area Manila 1018**, which shall be open to all interested parties.

Bids must be delivered to the address below on or before **25 November 2020, 9:00 A.M.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **25 November 2020, 9:00 A.M.** at **National Headquarters Philippine Coast Guard Conference Room, 2F Admin Building, 139 25th St Port Area Manila 1018**. Bids will

be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **Philippine Coast Guard** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
