

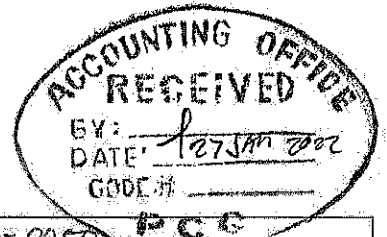



CONTRACT AGREEMENT

THIS AGREEMENT made the 31 day of DEC 2021 between **PHILIPPINE COAST GUARD** with office address at **139 25th Street, Port Area, Manila**, of the Philippines (hereinafter called "the Entity") of the one part and **MVDC TRADING & GENERAL MERCHANDISE** of 89 Malusak, Sta. Ana, Bulacan, Bulacan, Philippines (hereinafter called "the Supplier") of the other part;


WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **SUPPLY AND DELIVERY OF CGK9 GROOMING, KENNEL AND TRAINING SUPPLIES (LOT 2)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION FOUR HUNDRED EIGHTY-NINE THOUSAND THREE HUNDRED THIRTY PESOS (P1,489,330.00)** (hereinafter called "the Contract Price").

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;



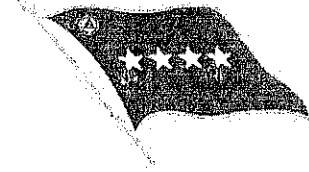
