CONTRACT AGREEMENT

THIS AGREEMENT made the 07 day of September 2021 between **PHILIPPINE COAST GUARD** with office address at **139 25th Street, Port Area, Manila**, of the Philippines (hereinafter called "the Entity") of the one part and **TAHANANG WALANG HAGDANAN, INC** of **175 Aida Street Marick Subdivision Brgy. Santo Domingo, Cainta Rizal** (hereinafter called "the Supplier") of the other part;

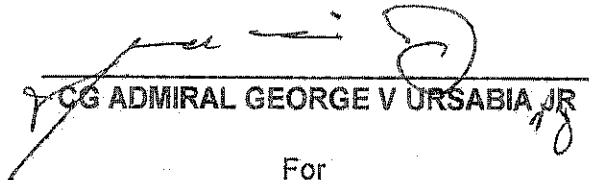
WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **SUPPLY AND DELIVERY M14 DUMMY RIFLE** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION NINE HUNDRED FORTY THOUSAND PESOS ONLY (P1,940,000.00)** (hereinafter called "the Contract Price").

 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

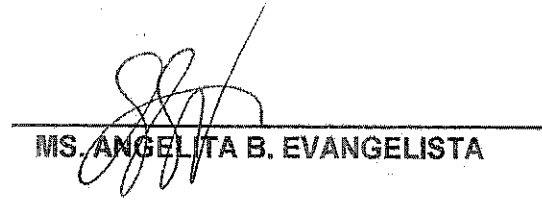
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
